

MINUTES OF THE WOOLPIT PARISH COUNCIL MEETING HELD ON MONDAY
2 DECEMBER 2013 AT 7.30 P.M. IN WOOLPIT INSTITUTE

Present: Mr Wiley (Chairman), Mr Guyler, Mr Jones, Mr Smith, Mr Hardiman, Mrs Parker, Mr Melvin, Mr Lomax, County Cllr Storey, Suffolk Police and Crime Commission Tim Passmore and PCSO Pendergast.

Public comment – PCSO Pendergast advised that there were 2 crimes recorded between 2 November and 2 December including criminal damage to a car in Roman Fields where all 4 tyres were slashed. 48 events calls were received during the same period including 21 related to calls on A14 Woolpit area, 4 concern for welfare of people, 1 crime related and 3 for road traffic collisions. Sgt Pederick has taken over as the Sergeant at Elmswell Police Station. Malcolm McKessar has been appointed as Neighbourhood Watch Liaison Officer and is contacting all NW Co-ordinators. County Cllr Storey advised that the Cabinet will be meeting 3 December. The main item the Cabinet is asked to endorse the position of SCC as a signatory and lead partner in the Greater Ipswich City Deal aimed at transforming skills, young people's employment services and business growth and support across Suffolk and Norfolk. The second main item is to approve a three year investment plan to achieve accelerated and sustainable growth in apprenticeship numbers. Part of the Cabinet meeting is again given over to a report from the Chairman of the Scrutiny Committee. Later in the month the education scrutiny Committee will look at the recent Ofsted findings and also the education Other than at School Service. There is a full council meeting 19 December.

District Cllr Melvin has had a meeting with MSDC Chief Executive on outstanding issues in Woolpit and hopes that we will see some movement.

Mrs Parker advised that the hedge in Mill Lane at the back of properties in Cow Fair needs to be cut urgently. The Clerk will contact Orbit Housing

Mr Guyler attended the Parish Liaison meeting and the grant that MSDC gets from Government is heavily dependent on the New Homes Bonus.

Mr Hardiman advised that the streetlight by the school has been out since August. SCC has advised that it has been referred to UKPN as there is a problem with the cable/isolator.

To have discussions with the Suffolk Police and Crime Commissioner Tim Passmore on policing issues in the village.

Firstly the Parish Council praised PC Brown and PCSO Pendergast for the work they do within the parish. Full and frank discussion took place about speeding enforcement, anti-social behaviour, serious sexual offences and domestic violence - what is to be done to achieve improvements. Suffolk Constabulary is looking to increase the number of front line officers, PCSOs and specials. Our concerns regarding Neighbourhood Watch Scheme and Police Direct were acknowledged and steps are being introduced to improve communication from these areas of policing. Mr Passmore is meeting with the Highways Agency regarding lack of investment in the A14.

1. **Apologies for absence** were received from Mrs Cook.

2. **To receive declarations of interest.** Mrs Parker declared a prejudicial interest in item 12 and duly signed the interest book.

3. **To approve minutes of the meetings 4 November 2013.** The minutes were approved and signed.

World War I commemoration – Hessett PC has been in contact and they are to discuss at their next meeting and keep us informed. It may be that we can have a combined commemoration with other villages.

Dog & litter bins – MSDC is increasing services charges to £20 per litter bin and £25 per dog bin for 2014/15.

Land by cycle path – cars are parking on the grass area beside the cycle path cutting up the surface and putting mud on the path which makes it slippery. SCC will be informed.

Drawings have been submitted for the green area near to the bungalows. MSDC Planning Officer has asked for our opinion and recollection of meetings in 2008. Cllr Guyler's recollection is that the central area would be fenced and gated so as to be accessible to those nearby but to hinder the use of skateboards etc. Having reviewed the plans Cllrs feel that the paths through the green area should be the other way, fruit trees should be planted rather than conifers and any shrubs should be low and slow growing, the path should be asphalt rather than tegula blocks as these can become slippery in winter and are not user friendly for wheelchairs and pushchairs. Overall the scheme needs to be kept simple but neat and tidy for residents to sit in.
